Here are the reports that we (Jennifer Bowler and I) are asking you to read and review before we convene the Women's Council. Please do not share or discuss them with anyone besides your spouse.

The second report was written by me. I was one of several witnesses to, in one			
case,	perpetrated by	[MIQ] against	_[his wife] and others
while on our trip to	the UK. On the flight	home from London, two to three	days after the events
took place, I wrote	17 pages of notes in a	a spiral notebook. This report is	the transcription of
those notes.			

The third report is a personal message written to [the MIQ] by Aaron Bishop. Aaron texted it to [the MIQ] (via the iPhone Notes App) on Saturday, November 18, 2023, while we were driving to the conference in Edinburgh. Aaron was a primary witness to most of the events you will read in my report but had flown home a few days before the trip ended. When he found out that [the MIQ] was going to attend the conference despite all that had transpired the previous 6 days, Aaron sent the message to [the MIQ] to express his feelings of frustration.

I received Aaron's permission to include his message to [the MIQ] as one of the three reports. He had sent it to Dave and I shortly after sending it to [the MIQ]. We felt that it presented another primary witness account of the events. Especially since it came from one of [the MIQ's] best friends who dearly loved him and had no reason to misjudge or malign him. In fact, Aaron had flown to Scotland several days before the rest of us arrived in London so he could spend 2-3 days of one-on-one time with [the MIQ] while seeing the sites in Edinburgh.

We are hoping to convene the council this coming Sunday evening, January 7 at 7 pm.

However, if that is not possible for you and your schedule, please let me know a better evening that would work for you. In talking to a few members of the council, weeknights are very tricky due to children's school activities and sports. Therefore, we are thinking that Sunday evenings tend to be better for that reason.

If this Sunday does not work out for you, next Sunday, January 14, may be a possibility, but one of the members can't commit to that day until later in the week. The other possibility is Sunday, January 21.

Thank you for taking the time to consider these reports as we prepare to discuss them as a group and the implications they hold. I know we all take the matter of a Women's Council very seriously and are mindful to follow the Spirit as it leads and guides.
